JUDGES AND JURIES	<p>The Judges' panel is set up by a draw from the judges present at the event. Priority will be given to the highest categories. All judges must have a current valid FIG brevet at the time of the event, for the respective discipline.</p> <p>The participating member federations must send minimum one qualified judge if they participate with individual gymnasts. The organizing member federation will apply a fine of 100 eur per missing judge (to be paid to the LOC by 11 October 2026) should a federation fail to bring the required number of judges or judges without the requested qualification (brevet).</p>

If there are no convenient flights for participating delegations in those airports, the LOC will guarantee transportation to/from Budapest airport 70 eur/person (120 minutes from Nitra).</p> <p>The arrival date must be Wednesday or Thursday, 25-26 November 2026 and the departure date Sunday and Monday, 29-30 November 2026.
